3.7.1 PRIVATE MEMBERS BILL – PLANNING AND DEVELOPMENT ACT – THIRD PARTY APPEALS (ITEM 6.2.1)

Moved Cr Allen, seconded Cr Stock-Standen

That Council resolve in regards to the draft Private Members Bill – Third Party Appeals to:

- 1. Advise the Honourable Member for Alfred Cove, Dr Janet Woollard MLA that whilst the Council understands the Private Members Bill Third Party Appeals is well intentioned, it has grave concerns over the implications of the draft legislation, as the Draft Bill will:
 - a. Place significantly greater financial burden on smaller Local Authorities through:
 - i. An increased referral process for development applications:
 - ii. The need to undertake further amendment to its existing Town Planning Schemes;
 - iii. Increased legal representation and expert advice to address the third party appeals; and
 - iv. Increased administrative support to address third party appeals.
 - b. Impose greater delays on processing applications and handing down decisions of Council through the planning process, notwithstanding the increased burden on the development industry at a time when criticism is directed at the planning process and local government for being too bureaucratic;
 - Provide an opportunity for aggrieved parties to lodge vexatious claims of objection against Council decisions causing unnecessary delays at great cost through the appeals process;
 - d. Impose a greater burden on the State Administrative Tribunal, again causing an increase in cost and delays contrary to calls from the development industry to improve the planning process.

It is the view taken by this organisation that individual Councils are elected to represent the interests of the whole community and make valued and informed judgements and decisions on planning matters pursuant to the operational function, permissibility and discretion afforded under respective Town Planning Schemes. The Council is concerned 'Third Party Appeal' legislation could be abused by some individuals and groups to the detriment of the planning process.

2. Support WALGA's recommendation that:

- a. The member for Alfred Cove, Dr Janet Woollard MLA and the Minister for Planning and Development, Hon Alannah MacTiernan be advised of the inaccuracies and duplications contained in the proposed *Planning and Development Amendment (Third Party Appeals) Bill 2007*; and
- b. As there is no justification for the proposed legislation and there are significant negative implications for Local Government, industry and the community, Local Government continues to be opposed to the introduction of third party appeal rights in Western Australia.

- 1. Alter wording of Section 4.3.3 whilst also noting that it is a "licensed non-potable water supply":
 - "...current water supply is a licensed non-potable water supply that is operated by the Shire of Northampton and is not to a potable standard considered acceptable by the Water Corporation."
- 2. Include additional provisions relevant to SPP 3.5 Historic Heritage Conservation within Section 2.1.2 State Planning Framework;
- 3. Modify section 7.1.4 and 7.2.1 to include the following:
 - Ensure that protection of heritage places is provided through a comprehensive heritage schedule in the Northampton planning scheme.
 - Ensure that new developments in the town are sympathetic to adjacent heritage buildings.
 - Maintain Council-owned heritage places in sound condition.
 - Encourage the conservation of privately-owned heritage places.
- 4. Include reference to State Water Plan and relevant objectives in Section 2.1.2 State Planning Framework;

- 5. Include general measures of SPP 2.9 Water Resources in Section 2.1.2 State Planning Framework;
- 6. Amend Section 2.1.2-SPP 2.7 as follows:

"...in the relevant location planning scheme. The LPS has identified the PDWSAs within the Shire and will include these areas as Special Control Areas within the relevant local planning scheme(s). These Special Control Areas will ensure that any changes in zonings, land use and future development reflect the applicable level of water source protection."

7. Amend Section 4.5.3 as follows:

Hydrology to specifically state the Water Reserves proclaimed under the Country Areas Water Supply Act 1947, located within the Shire - Yerina Spring, Port Gregory, Horrocks Beach and Northampton.

8. Amend Section 7.1.2 as follows:

Broadacre Precinct paragraph 3 to include a paragraph that specifically refers to the Yerina Spring Water Reserve, and also state that zonings, land uses and development applications are to be consistent with the Department of Water's Land Use Compatibility in Public Drinking Water Source Areas publication or be referred to the Department of Water for assessment.

9. Include additional Strategy/Action to Section 7.1.2 as follows:

The <u>strategy</u> "To manage and protect natural resources"
The <u>action</u> to "Identify and protect water resources in the region for future population and economic growth needs by Special Control provisions"

- 10. Include addition to Appendix B under the "Environment" heading as follows:
 - (h) Is the proposal located within a Public Drinking Water Source Area? If so, is the proposal consistent with the Department of Water's Water Quality Protection Note, Land Use Compatibility in Public Drinking Water Supply Areas?
- 11. Modify all references made to "water source" (in terms of town water supply) to "public drinking water source";

12. Include addition to Section 4.5.2 – Soils as follows:

The Shire of Northampton has a legacy of mining activity which may have led to lead contamination of some soils in the vicinity of historic workings and dumps.

- 13. Modify Section 5.4 Yerina Dissected Area, by omitting examples emus, ostriches and goats;
- 14. Include addition to Section 6.4 Tourism and Recreation, by noting that a range of coastal day use sites provide opportunities for nature based recreation/environmental protection;
- 15. Amend Section 6.5 Environment and Conservation as follows:

Remnant vegetation within crown reserves and UCL is subject to degradation due to uncontrolled access and use. Areas of high environmental significance presently under threat include the Bowes and Hutt River mouths and the Murchison River corridor.

16. Include addition to Part 7 – Strategies and Actions as follows:

Natural values will be protected and conserved, and sustainable practices will be promoted and recognised as essential for maintaining economic and social values.

- 17. Include addition to Section 4.2 Population and Housing and Section 4.3 Settlement Pattern and Infrastructure to include population data from the 2006 Census;
- 18. Amend Section 7.1.3 (Economy/Action) to include a reference to a low-key tourism node at Lot 4484 and Lot 9424 White Cliffs and Port Gregory Roads, White Cliffs and amend Local Planning Strategy Plan to include a "Low-Key Tourism Node" over the same landholding (refer Attachment A10);
- 19. Modify boundary of Figure 8 "Special Control Area" and Local Planning Strategy Plan (Major Growth Townsite-Horrock's) to reflect topographical boundaries rather than property boundaries. Include Part of Lot 27 along the ridgeline and west of ridgeline and omit part of Lot 112 east of ridgeline (refer Attachment A11-A12);
- 20. Modify Figure 5 by including Lot 20 and Lot 5 Yarra Road, Oakabella within the "Rural Smallholdings 40ha" zone as per the initial plan adopted by Council on 20 October, 2006 (refer Attachment A13) and also modify Figure 5 by extending the "Rural Smallholdings 40ha" zone over Lot 29 Hatch Road and Lot 111 Hatch Road, Oakabella to create uniformity over the landholdings.

- 21. Modify Figure 7 to include Lot 820 Isachar Back Road, Northampton as "Rural Residential" and also include Lot 820 within the Local Planning Strategy Plan (Major Growth Townsite-Northampton);
- 22. Modify Figure 5 by including Lot 20 and Lot 5 Yarra Road, Oakabella within the "Rural Smallholdings 40ha" zoning as per initial plan adopted by Council on 20 October, 2006 (refer Attachment A13);
- 23. Modify Figure 7 to include Lot 380 Stephen Street, Northampton as "Residential R5".

ADVICE NOTES:

- 1. The Shire is not supportive of lot sizes smaller than 40ha in this location. Submitter No. 19 be advised that the aim of the LPS is to consolidate the existing townsites of Horrock's and Northampton, both of which are considered to offer lifestyle options for people moving to the Midwest Region. The Shire is not supportive of "new townsites" in locations close to the Oakajee Port. Furthermore, Coronation Beach is not located in the Shire of Northampton and is not subject to this LPS.
- 2. The Shire is supportive of the eastern portion of Lot 112 being subdivided into a separate title should the "Special Control Area" boundaries of Figure 8 be agreed to.
- 3. The Shire is supportive of Lot 366 being rezoned to a "Special Site" for holiday accommodation purposes.
- 4. The Department of Industry and Resources be advised that the Shire does not support their submission and Council wishes to express their strong dissension to the proposals put forward in their submissions.

1. The retaining wall being reduced from 3 metres to 1.8 metres along the front boundary of Lot 26 and stepped back to 3 metres;

- 2. Amended plans being received by the Local Government, detailing a reduction in the retaining wall in accordance with Condition No. 1 above;
- 3. Adequate notification and protection must be given to adjoining properties and buildings where compaction/vibrating equipment is to be used for earthworks;
- 4. Any soils disturbed or deposited on site shall be stabilised to the approval of the local government;
- 5. Prior to the issuing of a Building Licence, the retaining wall plans are to be certified by a Structural Engineer; and
- 6. The Applicant/Landowner is to ensure that appropriate dust control measures are implemented for any bulk earthworks.

Advice Notes:

- 1. Compliance is required with all current Building and Health By-Laws and Regulations within the Shire of Northampton; and
- 2. Compliance is required with the Building Code of Australia.

4. Water Ski Areas

Port Gregory – all waters between a line commencing at a point on the foreshore 0.8 kilometres south-east of the Port Gregory Jetty and extending in a southerly direction to the reef and a line commencing at a point on the foreshore 1.5 kilometres south-east of the Port Gregory Jetty and extending in a southerly direction to the reef PROVIDED HOWEVER that no boat or skiers shall approach within 20 metres of the beach or reef except for landing or take off purposes.

• PART 9 – THE REGIONAL MODEL

The concept proposed within the report of a regional based Council structure is supported.

It is recognised those local governments that are sustainable still have the option of being involved in a Regional Council if they so wish.

It is further recognised that some small local authorities may still need to be amalgamated with neighbouring Councils to make the regional area more economically sustainable and for their own local government to be sustainable.

SCHEDULE OF RECOMMENDATIONS COMMENTS

<u>Recommendation 1</u> – Although asset management plans are supported, to make them mandatory as prescribed legislation could cause concern, especially if the plan requires cash reserves to make the plan achievable.

Cash backed plan would be difficult to achieve and believe this recommendation needs further clarification and exploration before being implemented.

The issue of key performance indicators is a valuable tool to gauge how the Council is performing, however with previous experiences in annual reports etc being made available to the public it is questionable how much notice the electors will take of KPI reports.

Recommendation 2 – although officer and councillor training is supported, Council does not support compulsory training for councillors as are of the belief it could be a deterrent to attract new councillors to rural local authorities where it is difficult enough to attract new councillors.

Council also considers that the public will be the deciding factor in determining what Councillors are elected irrespective of the type of training. It must be recognised that some persons can have all the qualifications and training but are in cases not that good at their job so we need to be wary of this and not take away the "peoples vote".

Recommendation 10 – the current financial reporting requirements do not apply as one across the sector. The Queensland concept is not known but if all local government reporting requirements were the same then that would no doubt be in the best interest of local government.

<u>Recommendation 30</u> – the recommendation is for monthly rate payments. This is not considered too much of an impost however may have cash flow implications for some local governments.

Monthly repayments are now a common issue for the average household for payment of insurances, hospital benefits etc. The only stipulation here though is that as there is no instalment notice there may need to be a mechanism to provide that direct debits from a nominated bank account be allowed as this guarantees the monthly payment as opposed to personally making monthly payments.

<u>Recommendation 53</u> – the recommendation advocates refresher training courses for Councillors every four years. This again could be seen as a deterrent from attracting new Councillors and believe this should not be mandatory.
