It is considered that the composition and functions of the Committee are fit for purpose, however the statutory requirement for an Independent Person to be appointed as Presiding Member of the Committee needs to be implemented.

As a short-term option to get through the Annual Financial Report as part of the next Audit and Risk Management Committee meeting the Chief Executive Officer (CEO) has had a discussion with the Shire of Chapman Valley about a pro-quo arrangement whereby each CEO would become the Independent Member of each other's Committee for a six month period at no cost to either organisation. This is permitted under the legislative changes (noting that Councillors are specifically excluded from doing this for reason unknown). Following this both Local Government's would be able to review to determine whether to continue or whether to seek an alternate arrangement. The alternate to this is that Council request the CEO attempt to source an Independent Person to be the Presiding Member.

It is recommended that Council update the Terms of Reference including the name of the Committee to the Audit, Risk and Improvement Committee as per the attachment to reflect this proposal.
